



The County Board of Winona County ordains:

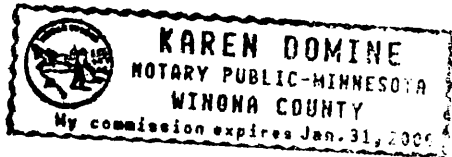

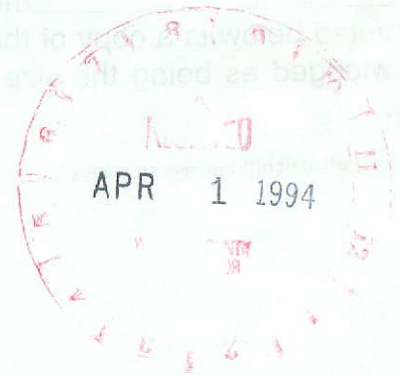
